Office hours policy

- If the class is face to face, the College policy on wearing masks and social distancing:

Attendance

Tech-Related Language

Because of the continued remote instruction requirement due to the COVID-19 pandemic, this course will use _____ (Canvas Conference/ Webex) for some synchronous (“real time”) class meetings. Meeting dates and times will be scheduled through Canvas and should appear on your calendar.¹ (An instructor would need to add the Canvas Conference to the calendar – it is not there automatically. WebEx does add a scheduled meeting to the Canvas Calendar.)

This class or portions of this class will be recorded by the instructor for educational purposes. These recordings will be shared only with students enrolled in the course and will be deleted at the of the _____ course. Your instructor will communicate how you can access the recordings.²

Some of the sessions in this course will be recorded or live-streamed. Such recordings/streaming will only be available to students registered for this class. These recordings are the intellectual property of the faculty and they may not be shared or reproduced without the explicit, written consent of the faculty member. Further, students
